

AN ORDINANCE AMENDING ORDINANCE NUMBER 1023, ORDINANCE NUMBER 1057, ORDINANCE NUMBER 1067, ORDINANCE NUMBER 1075, ORDINANCE NUMBER 1088, ORDINANCE NUMBER 1092, ORDINANCE NUMBER 1107, ORDINANCE NUMBER 1115, ORDINANCE NUMBER 1126, ORDINANCE NUMBER 1138, ORDINANCE NUMBER 1144, ORDINANCE NUMBER 1154, ORDINANCE NUMBER 1235, ORDINANCE NUMBER 1243 AND ORDINANCE NUMBER 1250; AND PRESCRIBING THE RATES AND CHARGES TO BE CHARGED BY THE WATER DEPARTMENT OF THE CITY OF RAYMONDVILLE, TEXAS FOR THE FURNISHING OF WATER AND SEWER SERVICES TO THE INHABITANTS OF SAID CITY; PRESCRIBING THE RATES TO BE CHARGED FOR INHABITANTS OUTSIDE THE CITY LIMITS; PROVIDING THAT OTHER PROVISIONS OF ORDINANCE NUMBER 1023, ORDINANCE NUMBER 1057, ORDINANCE NUMBER 1067, ORDINANCE NUMBER 1075, ORDINANCE NUMBER 1088, ORDINANCE NUMBER 1092, ORDINANCE NUMBER 1107, ORDINANCE NUMBER 1115, ORDINANCE NUMBER 1126, ORDINANCE NUMBER 1138, ORDINANCE NUMBER 1144, ORDINANCE NUMBER 1154, ORDINANCE NUMBER 1235, ORDINANCE NUMBER 1243 AND ORDINANCE NUMBER 1250 AMENDED SHALL REMAIN THE SAME; AND DECLARING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT ON OCTOBER 1, 2022.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF RAYMONDVILLE, TEXAS:

- (1) THAT Section 1 of Article I of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:

Section 1. Rates for service within the City Limits. The following rates are hereby effective for water service within the City Limits of the City of Raymondville:

A. Residential Rates:

0-2,000 gals.	\$ 23.01
Over 2,000 gals.	\$ 4.51 per 1,000 gals.

B. Commercial Rates:

Minimum	\$ 23.01
Per 1,000 gals.	\$ 4.51

- (2) THAT Section 2 of Article I of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:

Section 2. Rates for service outside the City Limits. The following rates are hereby effective for water service outside the City Limits of the City of Raymondville:

A. Residential Rates:

0-2,000 gals.	\$ 32.97
Over 2,000 gals.	\$ 6.85 per 1,000 gals.

B. Commercial Rates:

Minimum	\$ 32.97
Per 1,000 gals.	\$ 6.85

- (3) THAT Section 3 of Article I of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:

Section 3. Minimum Monthly Charges within the City Limits. The following monthly minimum charges are hereby effective for water service within the City Limits of the City of Raymondville:

For a five-eighths by three-quarter inch services	\$ 23.01
For a one inch service	\$ 23.49
For a one inch and one-quarter service	\$ 24.19
For a one inch and one-half service	\$ 24.92
For a two inch service	\$ 32.84
For a three inch service	\$ 63.60
For a four inch service	\$117.71

- (4) THAT Section 4 of Article I of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:

Section 4. Monthly Minimum Charges outside the City Limits. The following minimum charges are hereby effective for water service outside the City Limits of the City of Raymondville:

For a five-eighths by three-quarter inch service	\$32.01
For a one inch service	\$35.10

For an inch and one-quarter service	\$39.90
For a one inch and one-half service	\$45.90
For a two inch service	\$ 61.90
For a three inch service	\$119.90
For a four inch service	\$221.90

Section 1. Rates for service within the City Limits. The following rates are hereby effective for sewer service within the City Limits of the City of Raymondville:

A. Residential Rates

0-2,000 gals. water used	\$ 19.34
Over 2,000 gals. water used	\$ 2.32 per 1,000

B. Commercial Rates:

0-2,000 gals. water used	\$ 19.34
Over 2,000 gals. water used	\$ 2.32 per 1,000

- (6) THAT Section 2 of Article II of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:

Section 2. Rates for service outside the City Limits. The following rates are hereby effective for sewer service outside the City Limits of the City of Raymondville:

A. Residential Rates

0-2,000 gals. water used	\$ 27.65
Over 2,000 gals. water used	\$ 4.01 per 1,000

B. Commercial Rates:

0-2,000 gals. water used	\$ 27.65
Over 2,000 gals. water used	\$ 4.01 per 1,000

(7) THAT all other terms and provisions of Ordinance No. 1023, Ordinance No. 1057, Ordinance No. 1067, Ordinance No. 1075, Ordinance No. 1088, Ordinance No. 1092, Ordinance No. 1107, Ordinance No. 1115, Ordinance No. 1126, Ordinance No. 1138, Ordinance No. 1144, Ordinance No. 1154, Ordinance No. 1235, Ordinance No. 1243 and Ordinance No. 1250, shall be amended to read as follows:


