

**ORDINANCE NO. 1259**

**AN ORDINANCE OF THE CITY OF RAYMONDVILLE, TEXAS,  
AMENDING ORDINANCE NO. 977, ORDINANCE NO. 1102,  
ORDINANCE NO. 1113, ORDINANCE NO.'S 1133, 1161, 1169, 1234, 1244  
AND ORDINANCE NO. 1251, TO SET NEW SERVICE FEES FOR  
RESIDENTIAL AND SMALL COMMERCIAL UNITS AND SETTING AN  
EFFECTIVE DATE.**

**WHEREAS**, the City of Raymondville has received notice from the City's Contractor that the rates for collection of garbage, refuse, rubbish and other matter defined in Ordinance No. 977, Ordinance No. 1102, Ordinance No. 1113, Ordinance No. 1133, Ordinance No. 1161, Ordinance No. 1169, Ordinance No. 1234, Ordinance No. 1244 and Ordinance No. 1251, for Residential and Small Commercial Units as defined in said Ordinances are being increased; and,

**WHEREAS**, the Board of Commissioners has determined that in order to cover such increase in rates, it is necessary for the City of Raymondville to increase the rates charged to its Residential and Small Commercial Units.

**NOW, THEREFORE, BE IT ORDANINED BY THE BOARD OF  
COMMISSIONERS OF THE CITY OF RAYMONDVILLE, TEXAS, THAT,**

1. The service fee for Residential Units be set at \$19.93 per month and additional Automated Carts set at \$7.31 each per month.
2. The service fee for Small Commercial Units be set at \$28.64 per month and additional Automated Carts set at \$10.40 each per month.
3. Subsections (a) and (b) of Paragraph 4.01 of Section 4 of Ordinance No. 977, Ordinance No. 1102, Ordinance No. 1113, Ordinance No. 1133, Ordinance No. 1161, Ordinance No. 1169, Ordinance No. 1234, Ordinance No. 1244 and Ordinance No. 1251, are hereby amended to read as follows:
  - (a) The service fee for Residential Units is hereby set at \$19.93 per Residential Unit per month. This fee shall include curbside collection of Residential Refuse from the Automated Carts one (1) time per week and curbside collection of Bulky Waste and Rubbish one (1) time per month. The fee for additional Automated Carts for Residential Units is hereby set at \$7.31 per additional Automated Cart.
  - (b) The service fee for Small Commercial Units is hereby set at \$28.64 per Small Commercial Unit per month. This fee shall include curbside collection of Commercial and Industrial Refuse, not including Bulky Waste, from the Automated Carts one (1) time per week and curbside collection of Bulky Waste and Rubbish one (1) time per month. The fee for additional Automated Carts for Small Commercial Units is hereby set at \$10.40 per additional Automated Cart.

4. All other terms of said Ordinance No. 977, Ordinance No. 1102, Ordinance No. 1113, Ordinance No. 1133, Ordinance No. 1161, Ordinance No. 1169, Ordinance No. 1234, Ordinance No. 1244 and Ordinance No. 1251 shall remain the same.
5. This Ordinance and the fees set out herein shall be effective immediately after adoption of this Ordinance by the Board of Commissioners.
