City of Raymondville, Texas Water Utility Service Agreement

I. Purpose: The City of Raymondville is responsible for protecting the drinking water.

Supply from contaminated or pollution which could result from improper plumbing practices. The purpose of the service agreement is placed to provide this protection. The City enforces these restrictions to ensure the public health and welfare. Each customer must sign this agreement before the City of Raymondville will render any services. In addition, we will not re-establish service unless a signed copy of this agreement is obtained.

II. Plumbing Restrictions: The following are unacceptable plumbing practices which are prohibited by state regulations.

- A. No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air gap or an appropriate backflow prevention device.
- B. No cross-connection between the public drinking water supply and a private water system is permitted. These potential threats to the public drinking water supply shall be eliminated at the service connection by installation of an air gap or a reduced pressure zone backflow prevention device.
- C. No connection which allows water to be returned to the public drinking water supply is permitted.
- D. No pipe or pipe fittings which contains more than 8.0 lead may be utilized for installation or repair of plumbing at any connection which provides water for human use.
- E. No solder or flux which contains more than .2% lead can be used for installation or repair of plumbing connections which provides water.

III. Service Agreement. The following are the terms of the service agreement between the City of Raymondville and to all customers:

- A. The City of Raymondville will maintain a copy of this agreement as long as the customer and/or the premises are connected to the City of Raymondville's water system.
- B. The customer shall allow his/her property to be inspected for possible cross-connection and other unacceptable plumbing practices. These

designated agent prior to initiating new water service when is reason to believe that cross-connection or other unacceptable plumbing practices exists or any other major changes to the private plumbing facilities. The inspections shall be conducted during the City of Raymondville's normal business hours.

C. The City of Raymondville shall notify the customer in writing of any cross-connection or other unacceptable plumbing practices which have been identified during the initial inspection of the periodic re-inspection. There is to be absolutely no multi-property water supply service sharing. The City of Raymondville shall immediately take action from suspending to terminating water services until the unapproved connection is remedied.

D. The customer shall immediately correct any unacceptable plumbing practices on his/her premises.

E. The customer shall, at his/her expense, properly install, test, and maintain any backflow Prevention device required by the City of Raymondville.

IV. Enforcement. If the customer fails to comply with the terms if the service agreement, the City of Raymondville shall, at its option either terminate service or properly install, test, and maintain an appropriate backflow prevention device at the service connection. Any expenses associated with the enforcement of this agreement shall be billed to the customer.
